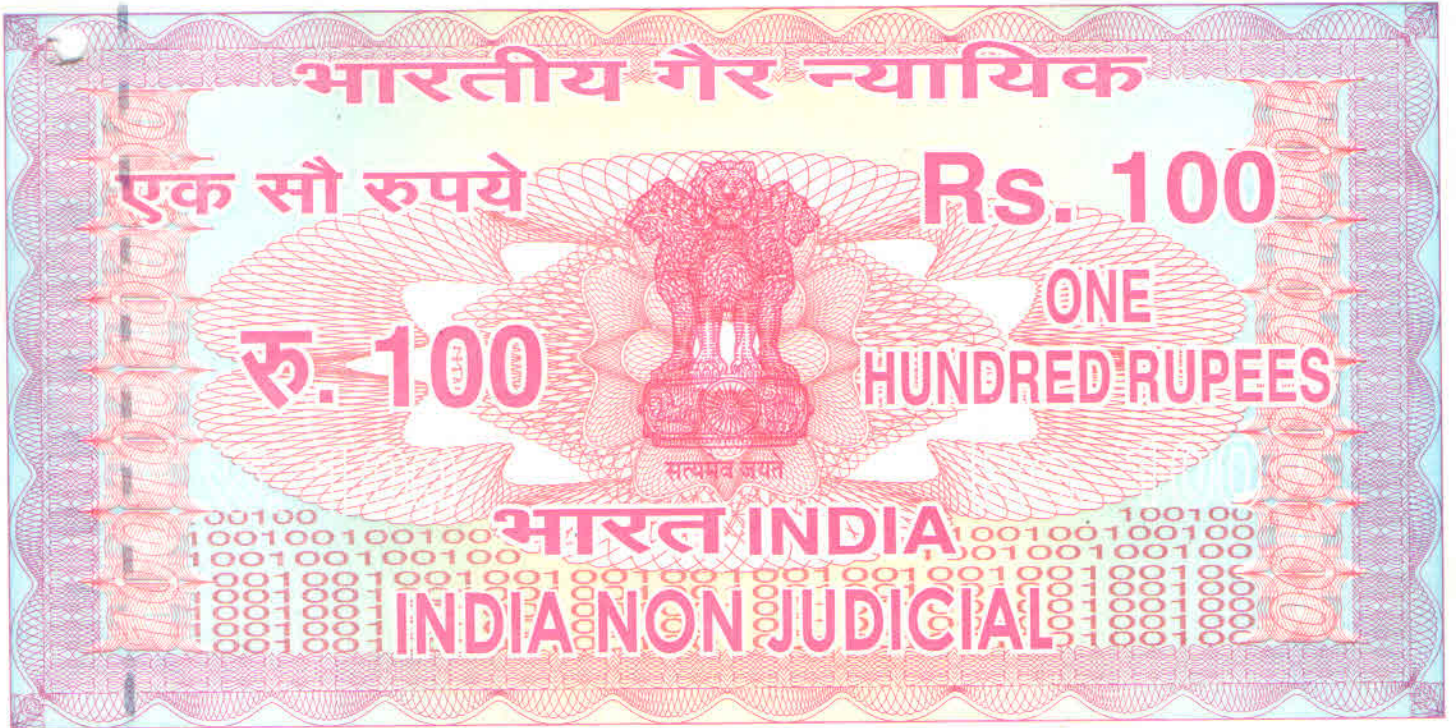
3. OBJECTS

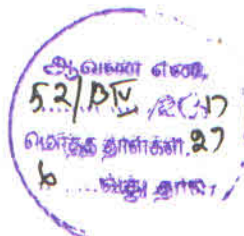

- (o) To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields.
- (p) To carry and to undertake any other activities that are incidental and ancillary to the attainment of the above objects of the trust.

The above objects would be carried out without any profit motive and in India. If any of the above objects are contrary to the requirements of the public charitable trust or not consistent with the requirements of a public charitable trust or not consistent with the requirements of exemptions under S 11, 10(23C) of the Income tax Act or any other act as regards a public charitable trust for grant of any concessions for such trust in taxation, the object will be treated as modified so as to be consistent with such laws or analogous provisions of the Income tax Act 1961 or such other statutes. All the objects of the trust and its activities will be carried on without any distinction on account of caste, creed, color, sex or religion.

The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion. the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

4. TRUSTEES:

The affairs of the trust will be managed by the Board of trustees.

The number of Trustees including the Author of the Trustees shall not be less than 2 and not more than 10 persons.

All the trustees holding Office at any time shall be collectively referred to as Board ..

The Board of the Trustees shall have the power to co opt one or more persons as trustees.

No person shall be eligible to be appointed as Trustee and trustee shall cease to hold Office (whether as trustee or Managing trustee) if :

He or she becomes a person of unsound mind.

He or she has been convicted of an offence involving moral turpitude

He or she has been or is an un discharged insolvent

He or she is otherwise disqualified to act as trustee according to the provisions of the Indian trust Act 1872

Trustee also vacates Office in the following circumstances

(i) if he dies, ii) if he resigns, iii) if he is found to have acted against the interest of the Trust. iv) if it is unanimously decided by the Trustees specified above that his continuation in the Office is against the interest of the Trust. v) Upon expiry of the period up to which the Board of trustees have nominated the trustee.

5. Term of Office of the Trustees.

These Trustees shall hold office for such duration as may be specified by the board of trustees.

6. MANAGING TRUSTEE: (i) The day-to-day administration of the Trust shall be looked after by the Managing Trustee under the guidance, control and supervision of the Board of Trustees.

(ii) The Board of Trustees shall nominate one amongst the trustees as specified in para (4) above to be the Managing Trustee.

(iii) The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

Mr.C. Radhakrishnan shall be designated as the Managing Trustee, who shall be in charge of the day to day to day affairs of the Trust.

The Managing Trustee shall have overall power of superintendence over the affairs of the Trust and shall have in particular, the power to operate the bank accounts, borrow monies for the trust and carry out the objects of the trust.

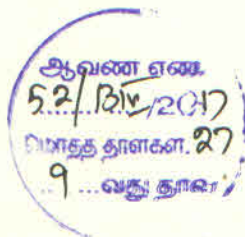

The Managing trustee shall have the residuary powers not explicitly assigned to any of the other Officers in these presents

7. Resignation :

Any trustee including the Managing trustee may retire from the Trusteeship hereof by giving 1 calendar month notice in writing to do so to the Board of trustees. The Board shall then consider such resignation and relieve the trustee after discussion of the above matter in the Board.

8. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in para(4) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

9. MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once in 3 months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust The meeting of the Board of trustee shall be convened by the Managing director and he shall preside over the meeting. In his absence the Trustees amongst themselves elect one person as chairman of the meeting to preside over the meeting.

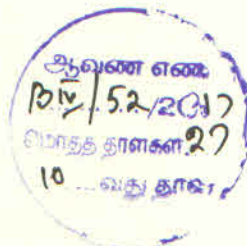
The Trustees shall keep minutes, in books kept for the purpose, of the proceedings at meetings of the Trustees and any sub-committee.

10. NOTICE:

7days Notice shall ordinarily be given in writing for a meeting of Board of Trustees unless all the Trustees agree to accept for a shorter notice .

11. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be 2 numbers quorum is required for a meeting adjourning for want of Quorum. A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the in the minute book and shall be signed by the Chairman of the Meeting.

12. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. All decisions shall be carried out by consensus and in case of difference of opinions by the majority of the Board. Any resolution in writing signed by all the trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees. The Person chairing the meeting shall have a casting vote in the event of equality of votes, in addition to his own.

13. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

(a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

(b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

(i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.

(ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.

(iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.

(iv) (a) To open one or more Bank accounts in the name of the Trust or Institutions under the Trust with any Nationalised banks, Private sector Banks and co operative banks .

(b) To raise loans, to receive monies, securities or other movable property on behalf of the Trust and to repay the same out of the income or funds of the Trust or any of its institutions. The Board shall offer such security or guarantee as may be required and resolved by the Board and shall also accept the security or guarantee that may be provided by the Trustee or any other persons as may be required and resolved by the Board.

(c) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.

(v) To award scholarship and make donations calculated to promote the objects of the Trust.

(vi) (a) To enter into contracts, or engagements on behalf of the Trust.

(b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs. (vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

(viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882. and not prohibited under Income Tax Act 1961

(ix) To sell, mortgage, grant, lease, hire, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust after satisfying all statutory compliances existing at that point of time

(x) To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

(xi) To appoint such employees on such terms and conditions as the managing trustee may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.

- (xii) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- (XIII) Towards the aforesaid objective, the trustees shall endeavour to obtain such exemptions from Income Tax and other local taxes and levies that may apply from time to time
- (xiv) To frame/rescind Bye-Laws and such other regulations as are required for achieving its objectives. The Trustees may from time to time make such reasonable and proper additional rules or regulations as they may deem necessary or expedient for the proper conduct and management of the Charity and which shall be binding on all the Trustees: provided that no rule or regulation shall be inconsistent with, or shall affect anything contained in, this Deed.

- (xvi) To file suit and defend suits, appeals, applications etc, on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- (xvii) In the event of any disputes between the trustees in relation to any manner pertaining to the Trust, the Courts in Kanchepuram district alone shall have the jurisdiction to try and dispose of the same .
- (xviii) to receive voluntary contributions from any person or persons from India or outside , after complying with the statutory formalities , by way of donation, gifts, or in any other manner and to hold the same upon the trust for the objects set forth herein.
- (xix) No trustee shall commit any act or breach of the trust fund or property or cause any loss to the trust property or commit fraud in the administration of the trust fund / property
- (xx) In the event Managing Trustee being absent, the available trustees shall discharge the functions of the aforesaid Managing trustee to the extent of day to day affairs of the trust, but do not possess the power to take any policy or major decisions which will have financial repercussions

- iv. All additions and accretions to the trust properties and the income there from

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties

17. ACCOUNTS:

The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant every year i.e., commencing from 1st April to the 31
